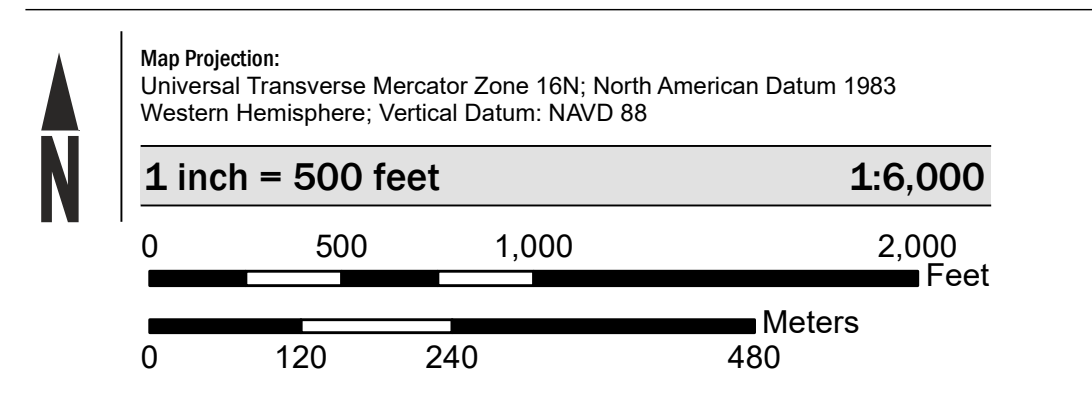
Base map information shown on this FIRM was derived from multiple sources. This information was photogrammetrically compiled at a scale of 1"=100' from aerial photography dated 2015.



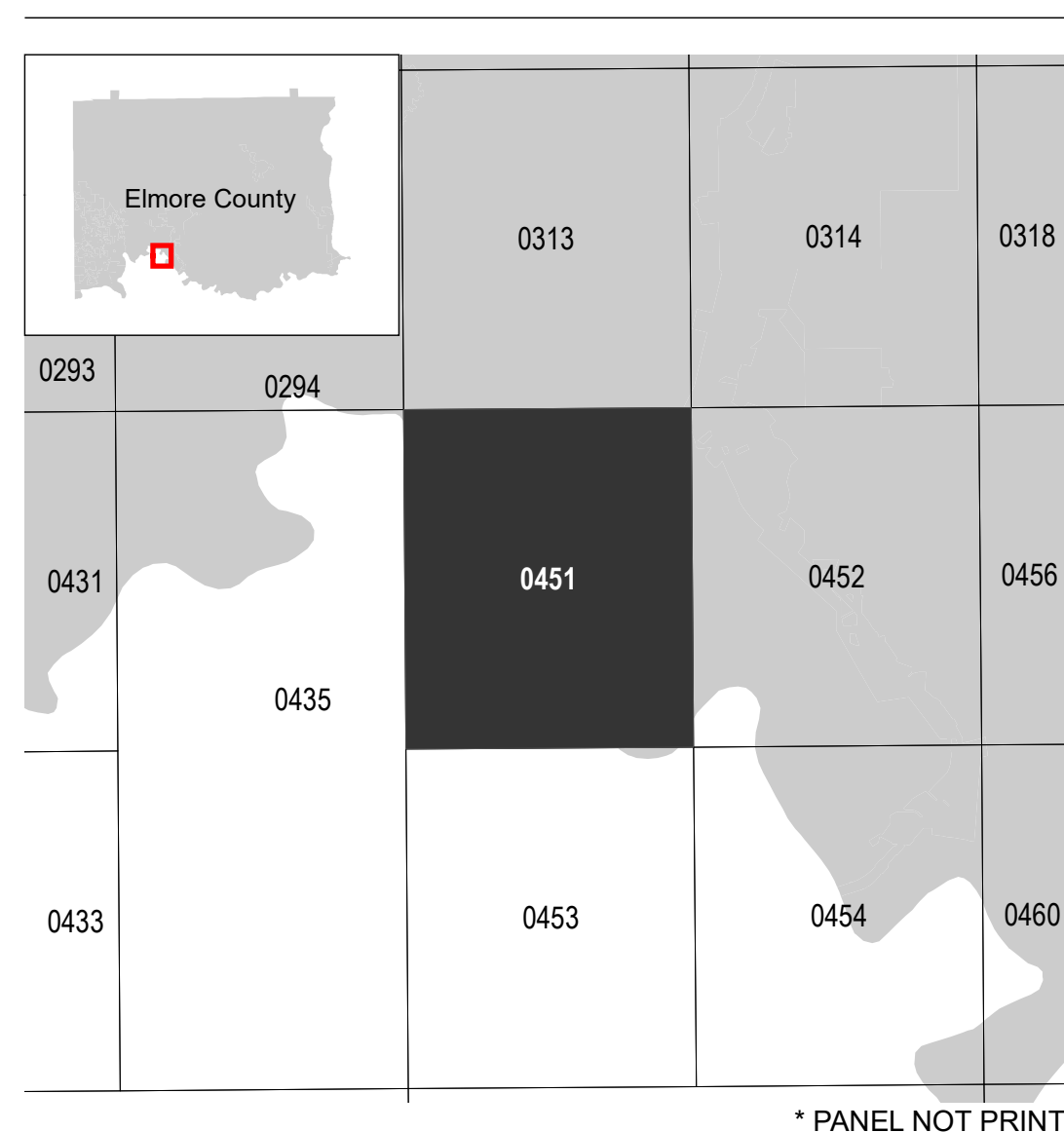
