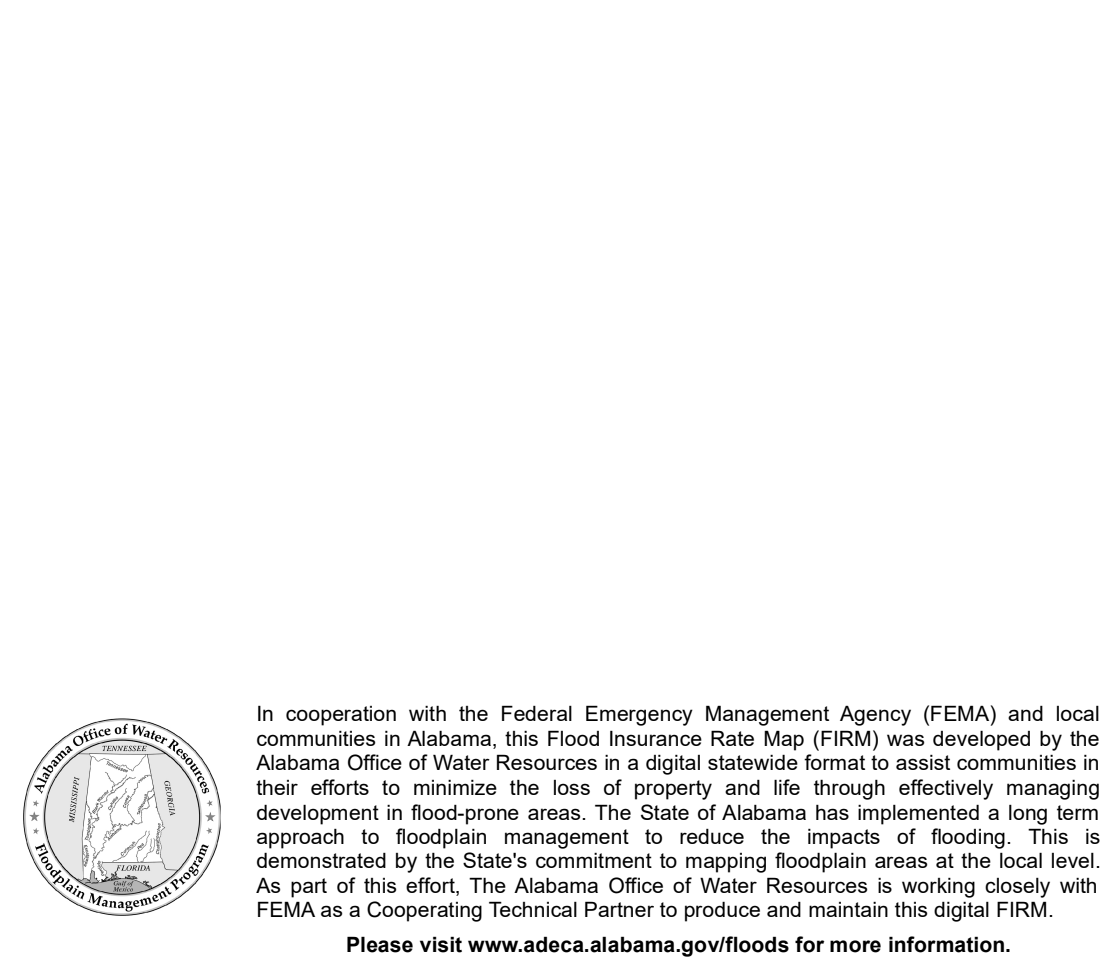

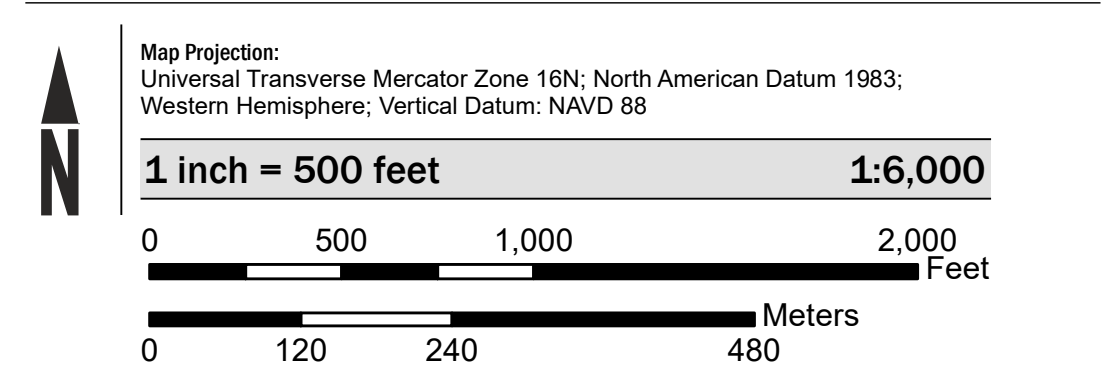

Aerials shown on the FIRM were provided by Jefferson County GIS Department. Data was collected in 2011 with a 1-foot cell size. 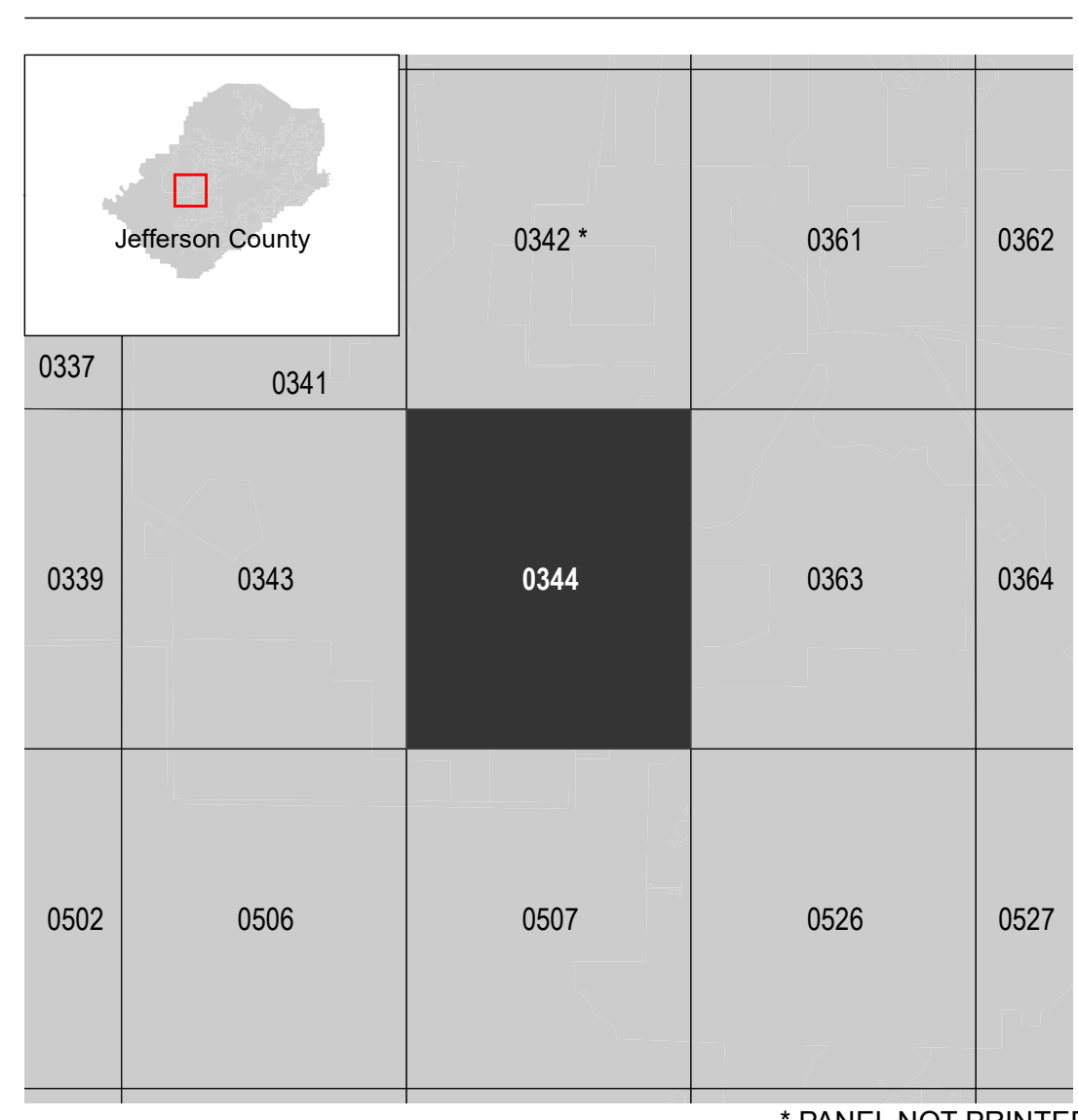
