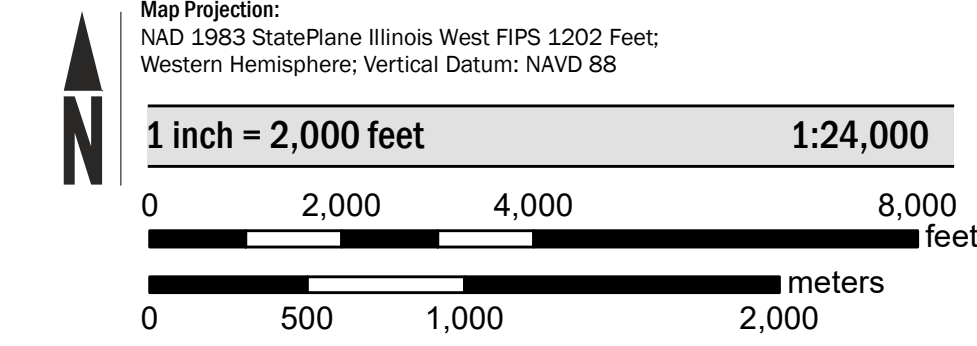

Base map information shown on the FIRM was derived from multiple sources. Transportation line data and political boundaries for the City of Columbia were provided by the United States Census Bureau (USCB). Water features including HUC-8 boundaries, water features, and water lines were provided either by the United States Geological Survey (USGS) as a part of their National Hydrography Dataset or by the Illinois State Water Survey (ISWS). Aerial imagery was provided by the United States Department of Agriculture (USDA). Source data for levees were provided by the United States Army Corps of Engineers (USACE). Source data for the Professional Land Survey System (PLSS) and additional political boundaries were provided by the Illinois State Geological Survey (ISGS).
