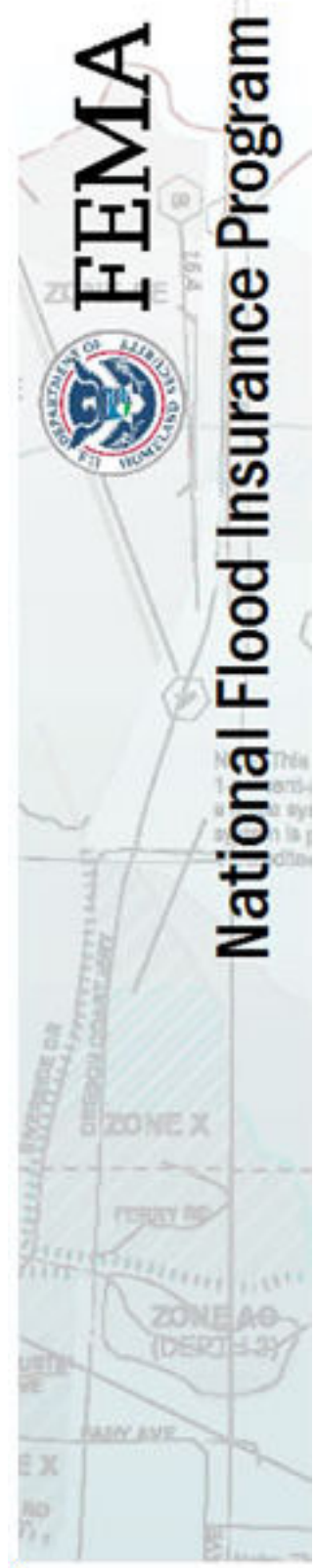
NATIONAL FLOOD INSURANCE PROGRAM FLOOD INSURANCE RATE MAP
